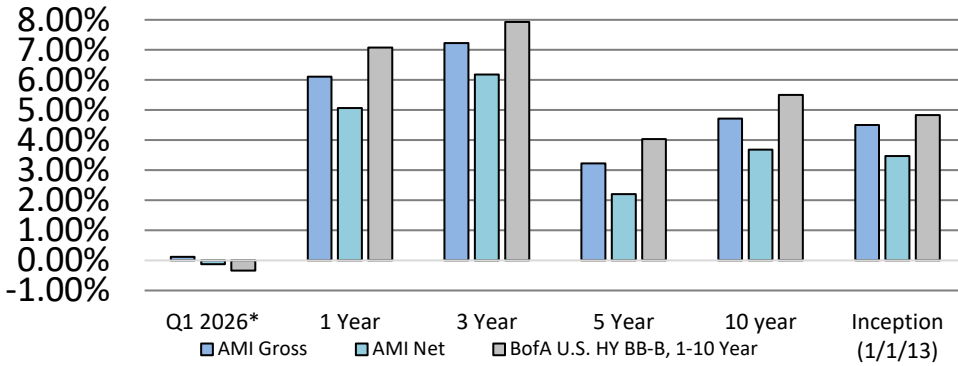

## Annualized Returns<sup>1</sup>



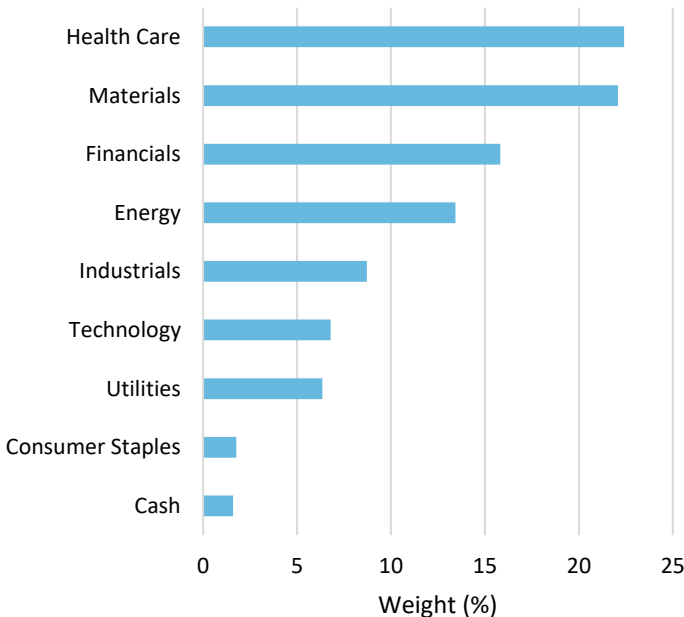

### Investment Philosophy and Process

- AMI's High Yield Fixed Income Strategy seeks to provide both income and capital growth by targeting opportunities beyond the constraints of traditional benchmarks.
- We believe that high yield indices are structurally flawed, as they overweight the most indebted issuers. Instead, our approach emphasizes smaller issuers, special situations, and a bias toward higher-quality BB-rated credits.
- Concentrated portfolio of between 25 and 50 registered bonds.
- We employ bottom-up fundamental security selection with top-down risk management.
